**New Business:** 

- Unit 1225 replacement of porch light with motion sensor light
  - Recommend keeping all lights uniform
  - o Goal is to have all back porch lights operating every night
  - Motion made and seconded to deny request
- Install Security Cameras on Unit 1262 motion approved
- Budget Committee
  - Report by Earl on budget committee activities with a goal of presenting the 2016 budget at the next board meeting
- Insurance
  - Earthquake insurance would be about \$11,000 per year addition to regular Insurance. Mike recommended dropping earthquake insurance and having a one-year contract at \$20,127 for the "standard" coverage
  - Motion by Lynn Kirlin to keep earthquake insurance for this year and look for a better plan next year.
    Motion failed with a vote 2 for and 4 against
  - Motion moved and accept "standard, basic" policy without earthquake coverage for this one year period
  - Comcast Contract
    - Mike reported Comcast <u>may</u> decrease current rate as much as \$10 per month per unit. New contract would be implemented at the end of our current contract.
    - o Earl reported that the cost decrease would be very beneficial for the budget
- Clubhouse Cleaning
  - Barb G. asked for monetary gift for current cleaner, upon her retirement at end of the year
  - Barb G. recommended selection of cleaning for next year of \$48 per month beginning 2<sup>nd</sup> Tuesday of January 2016
  - Motion accepted to give current cleaning lady a \$200 cash gift on her last day in December 2015
- Piano donation for clubhouse
  - o Donation offered by a resident of upright piano to be used in clubhouse
  - o Motion denied due to space considerations. Motion approved to write a sincere thank you note

- Clubhouse Exercise usage
  - o Caroline Yaude asked for permission to use the clubhouse for "Silver Sneakers" Exercise program
  - o Concerns expressed about Liability insurance
  - o Postponed request until next meeting pending further investigation on this request
- Report on acoustic improvement given
