Building and Grounds Report: (Larry Green)

- Clubhouse re-keyed and residents issued 2 keys
- Installed dead bolt on the furnace room door
- Large bee nest removed from under unit 5073

- Reserve Fund is at \$206,179.34
- 30 feet of new ground drain installed behind units 1205/1207
- Installed a locked key cabinet in the furnace room & moved all unit keys to the cabinet. The following units do not have keys in the cabinet 1237, 1250, 1262 and 5073. Also no paper work on file for unit 1250
- Replaced door and casing on door from living room to the deck at unit 1246 due to dry rot

Correspondence and Unfinished Business:

- A few notes were received regarding insurance
- Clubhouse Acoustics will be installed November 13, 2015
- Clubhouse usage request for exercise has been withdrawn
- Clubhouse cleaning contract will begin as of January 1, 2016 at \$50 per month
- IRS Refund: as a result Kirk's letter to IRS re: \$1724 refund, IRS informed him refund had been issued in July 2012 to association
- Comcast: Agreement for 5 year contract has been executed. Contract will be effective one year at the rate of \$41.24 plus fees and taxes for each unit per month. Down from \$54.00 per month per unit
- Insurance policy information: new policy has been instituted for one year and will not include earthquake insurance. Mike distributed a copy of the new insurance coverage.
