- 1. Call to Order: 10:00 A.M.

 - 3.1 General Fund Balance as of 2/28/17 is \$41,809.91. Reserve Fund Balance as of 2/28/17 is \$222,447.76.
 - 3.2 It was noted that there was an 8.6% increase for water/sewer costs on our first bill of the year whereas a 7% increase was what was budgeted.
 - 3.3 Office expenditures exceeded the budget. Resale Certificate income is budgeted at 4 sales per year and there have been two sales so far in 2017.
- 4. Building & Grounds Report given by Larry Green:
 - 4.1 Moss treatment on 35 roofs.

Gutter cleaning has now taken place on all houses.

Garage door panel replaced by the renter on #1223.

Garage door replaced on #1224.

Mountain Hemlock tree, lilac bush and over grown heather bush removed #1231.

Mugo Pine removed #1236.

Replaced glass in sky light & installed missing roof flashing #1262.

- 5. President's Comments given by Beverly Brownrigg:
 - 5.1 Information regarding a Joint Maintenance Agreement was passed out to the Board.
 - 5.2 New exercise class at Affinity is being offered and is free for Silver Sneakers or \$3 per class for those who don't have Silver Sneakers. Flyer posted on bulletin board.

6. Old Business:

Any large expenditures will be discussed in advance when possible. They will obtain bids and share them with us. The shared light fixture will be a shared cost and LED replacement will be considered. We will maintain the North side and they will maintain the South side of the road we share. There will be paperwork forthcoming.
- 7.2 Exercise classes in the Club House have not been allowed to date due to liability.
- 7.3 After discussion of Rhonda's request to use the Club House for an informational meeting for VACNCA homeowners only, on ways to improve blood circulation, Earl made a motion to allow Rhonda's request be accepted. Rhea seconded it and the motion was approved for a one time use. The meeting will be held March 24th at 1:00 and is open to all VACNCA residents.
- 7.4 Jo Anne's request to use the Club House on March 13th from 6-8 for an Art Club Meeting was deferred to Chairman Barb Green and approved.
