- 1. Call to Order: 10:00 A.M.
- 2. Larry moved and Earl seconded the board meeting minutes from January 11, 2018 be approved as written. The motion carried. The vote was unanimous.
- 3. Treasurer's Report: (Earl Sheneman)
- 3.1 All bills are paid to date
- 3.2 Three monthly assessment checks have not been received.
- 3.3 Quick Books Pro 2018 was purchased and now in use.
- 3.4 Reserve study this year cost more due to there being an on site visit.
- 3.5 Three signers are needed on the VACNCA's bank accounts. Cheryl Scheele was chosen to the be third signer on VACNCA's WECU Accounts. Rhea Ramsay has been removed as a signer.
- 3.6 Earl and Pete recommended that their reimbursement for copies they make be six cents per copy and the Board agreed. JoAnne questioned VACNCA's extra copies for non-required or essential notices. Rhonda has borne all those costs herself and VACNCA has not been charged for anything other than official VACNCA notices. Earl moved that the board set a reimbursement rate of six cents per copy for copies done for VACNCA by association members. Bev seconded and the motion carried with the Board voting in agreement.
- 3.7 The 2018 reserve study has been received and is located on top of the middle file cabinet. Pete offered to post a PDF copy on our website that members can access when needed as well as having the hard copy in the club house.
- 3.8 In the past, any additional monies left over from the previous year have been added to the reserve fund which is at 62% of the recommendation by David Bach. Earl moved that we transfer 2017's excess general fund monies, in the amount of \$6,299.00 to the reserve fund. Rhonda seconded and the board vote was unanimous.
- 4. Buildings & Grounds (Larry Pollett)
 - 4.1 Unit 1241 had a leaking toilet which cost approximately \$400.00 in water costs for VACNCA. The owner will reimburse the association for the plumber callout and repair.
 - 4.2 Unit 1265 garage door spring was broken and has been repaired and a new door and operator are on order. Also unit 1207 has a new garage door on order.
 - 4.3 Oscar has checked and cleaned all the gutters and has done some power washing as needed.
- 5. Landscaping (Cheryl Scheele)
- 5.1 Cheryl, Jerry Conger and Larry Pollett met with Custom Cut and obtained an estimate for the entry island in the amount of \$3,975.00 plus 8.7% tax of \$345.83. Insurance claim money paid for the island repair was in the amount of \$1,581.00.
 - The board approved the landscape committee's recommendation.
- 5.2 The committee will provide a signup sheet in the club house for those who want to have their patios &/or decks power washed at owner's expense.

Providing contact information is at each owner's discretion however it would be helpful for the association to know who to call if someone is gone and their house burns down!
- 7.4 Lynn suggested contacting Comcast to see if we can obtain free WiFi at the club house. The board gave Lynn the go ahead to investigate this proposal.
- 7.5 Dale French thanked the board for the power washing done and how the painted signs are now more visible. Larry Pollett reported that the road condition is showing the need now for a new seal coat and that that will more than likely be taking place this summer.
